Agreement of Affiliation (Memorandum of Understanding) Between The Catholic University of America, The Pontifical University of John Paul II, and The John Paul II Project

(hereinafter referred to as "Agreement")

The Catholic University of America (CatholicU), the national university of the Catholic Church, located in 620 Michigan Ave., N.E. Washington, DC 20064, The United States of America, represented by Vice Provost for Administration - Victor Nakas (hereinafter referred to as "home institution" or "CatholicU") and The Pontifical University of John Paul II in Krakow, located in 25, Kanonicza St. 31-002, Krakow, Poland, represented by Rector - Rev. Prof. Wojciech Zyzak (hereinafter referred to as "host institution" or "UPJP2") and the John Paul II Project, located in 10328 Green Mistletoe Court Orlando, Florida 32825, The United States of America, represented by President - Corinne MacDonald (herinafter referred to as "intermediary institution") hereby institute an agreement of affiliation with respect to CatholicU's participation in academic programs abroad.

This Agreement shall include the following features:

- 1. **Purpose**: The purpose of this Agreement is to continue an affiliation so that a set number of qualified CatholicU students are assured of admission to the academic programs offered by the host institution in another country.
- 2. Programs: The programs included in the scope of this Agreement are as follows:
 - a. JP2 Project (Summer)
- 3. **Principles of cooperation**: UPJP2 provides necessary data to intermediary institution. CatholicU students data are provided to UPJP2 by CatholicU and intermediary institution. UPJP2 does not transfer CatholicU students data to CatholicU. Intermediary institution fulfills the requirements of personal data protection set out in the Regulation (EU) 2016/679 of the European Parliament

and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation).

- 4. **Number of participants:** Catholic U agrees to collect and submit applications directly to intermediary institution by the deadline published every year.
- 5. **Duration of studies**: The duration of study will be one Summer Term each academic year for the duration of the Agreement.

6. Non-degree admission:

- a. CatholicU will recruit, select and nominate a small number of linguistically and academically qualified undergraduate students to enroll as non-degree students in instructional programs offered by UPJP2, which shall have final approval on non-degree admission. These students will not be candidates for degrees conferred by the host institution.
- b. Both institutions agree to accept only those students who participate under the conditions of this Agreement. Individual applications for direct enrollment or enrollment by arrangements with third parties will not be accepted.
- 7. Language of instruction: The language of instruction in the program is English.
- 8. **Terms of Affiliation:** Students participating under the terms of this affiliation Agreement will be entitled to participate in an orientation program organized by the intermediary institution, where students will be made aware of risks to health and safety and emergency procedures. Parties affirm they have written policies and procedures in place that provide for appropriate and responsive protocols in the event of a report of a safety violation or sexual assault or sexual harassment that are distributed to students by intermediary institution. Intermediary institution will provide copy of protocols to home institution upon request.

9. Financial Arrangements:

a. **Tuition:** CatholicU students will pay tuition to their home institution. Intermediary institution will invoice CatholicU the entire program amount for all participating CatholicU students.

b. Provisions and Requirements Pertaining to U.S. Financial Aid

1. Host institution certifies that it is has not had its eligibility and has no intention to participate in U.S. Title IV student financial aid programs terminated by the Department of

Education, and has not voluntarily withdrawn from participation in said programs under termination, show-cause, suspension, or similar activity initiated by a U.S. state licensing agency, accrediting agency, guarantor, or the Department of Education.

- 2. For purposes of awarding and disbursing financial aid, a CatholicU student participating in a program under this Agreement must be a degree candidate in good standing at CatholicU during the period of study at host institution. CatholicU will determine financial need and award funds to eligible students.
- 3. CatholicU will retain all authority and responsibility for administration of financial aid to CatholicU students participating in a program under this Agreement.
- 4. Host institution and intermediary institution agree **not** to provide any financial resources to the CatholicU student without the written permission of CatholicU.
- 5. A CatholicU student participating in a program under this Agreement will be considered in visiting status at host institution during the period of study noted on the contract.
- 6. A CatholicU semester student participating in a program under this Agreement must carry a course load equivalent to the full-time CatholicU academic load (i.e., 12 credits for undergraduates and 8 credits for graduates) to maintain financial aid eligibility during the program. For summer programs, students must enroll in at least 6 credits to be eligible for financial aid. Accordingly:
 - a. Enrollment confirmation must be provided by host institution or intermediary institution to the CatholicU Registrar's office before financial aid can be disbursed to the CatholicU student participating in the program; and
 - b. Intermediary institution agrees to immediately report to CatholicU any changes to a CatholicU exchange student's enrollment status while at host institution.
 - c. Intermediary institution agrees to notify CatholicU within 14 calendar days if a CatholicU student withdraws from host institution or stops attending all courses.
- 7. Host institution agrees to report to intermediary institution the academic course work completed by each CatholicU student participating in the program and the grades earned. Host institution must provide transcripts for CatholicU students in English. Intermediary institution provides the

above information as well as transcripts for CatholicU students in English to CatholicU.

- 10. **Room and Board:** The intermediary institution will provide room and full board (three meals a day) for the duration of the Program. All housing will be vetted for safety and suitability prior to the students' arrival.
- 11. **Health Insurance**: CatholicU students are required to be covered by CatholicU health insurance, which includes coverage for medical evacuation and repatriation. In some cases, the host institution will also require CatholicU students to be covered by their health insurance, which includes similar coverage. In this case, CatholicU's health insurance will act as the student's primary insurance while overseas.
- 12. Indemnification: CatholicU agrees to indemnify and defend UPJP2 against any loss or claim caused by the negligence of CatholicU or its agents, and UPJP2 agrees to indemnify and defend CatholicU against any loss or claim caused by the negligence of UPJP2 or its agents.
- 13. **Visas**: UPJP2 will facilitate the acquisition of appropriate visas/stay permits for CatholicU students. However, the students are ultimately responsible for obtaining required documents and visas/stay permits in compliance with all relevant requirements and immigration law.
- 14. **Facilities:** All facilities at the programs site(s) are available to students enrolled under this Agreement.
- 15. **Prompt Notification:** Intermediary institution will provide prompt notification to CatholicU of any "serious incidents" of which it is aware that occur involving CatholicU students. Host institution will provide prompt notification to intermediary institution of any "serious incidents" of which it is aware that occur involving CatholicU students. For the purposes of this Agreement, "serious incident" means: an actual or threatened tragic or traumatic event or situation, (within or outside of the host country) which affects, or has the potential to affect, a student, the student's family members or others including staff and friends in a traumatic way. This may include causing extreme distress, fear or injury. Serious incidents include, but are not limited to: (1) missing students; (2) severe verbal or physical aggression; (3) death, serious injury or any threat of these; (4) natural disaster; (5) assault, including sexual assault; (6) drug or alcohol abuse; (7) accusation of any student misconduct or criminal offense.
- 16. **Correspondence:** The official language of all correspondence between the partner institutions will be English. Applications and correspondence from all parties should be sent to the following designated offices:

- 17. **Terms of Agreement:** This Agreement is dated October 22, 2018 and will come into force upon signature by authorized representatives of all parties. It will continue for the period of **three** (3) years beginning with the 2019 Summer Term and conclude with the 2021 Summer Term. Either CatholicU or UPJP2 may terminate this Agreement by written notice to the other. Such termination will be effective **six** (6) months from the date of written notice. Should this occur, both institutions agree to carry out the terms of the Agreement for any student currently participating under the Agreement.
- 18. Changes to the Agreement. This Agreement may be modified, amended, or renewed by written consent of the parties signing below or by their legitimate successors.
- 19. Legal Jurisdiction: The law applicable to this Agreement is Polish law.
- **20. Personal Data:** Whereas General Data Protection Regulation is applicable in Europe, Parties of this Agreement confirm as follow:
 - a) UPJP2 is the data administrator provided by CatholicU and intermediary institution as well as data collected independently;
 - b) UPJP2 does not transfer data to CatholicU or other entity with a seat outside the European Union;
 - c) Intermediary institution is represented in Europe and fulfills the requirements set out in the General Data Protection Regulation.
- 21. **Resolution of Disputes:** Any dispute arising under or in connection with this Agreement which cannot be resolved by amicable discussions between the Parties shall be jointly referred to the legal authorities of both Parties or their nominees

for resolution. In case the dispute remains unresolved, it shall be resolved by the competent common court for the UPJP2.

The parties signing below for CatholicU, UPJP2, and The John Paul II Project hereby warrant and represent that they have right, power, and authority to execute this Memorandum of Understanding on the date signed.
